24 HOUR ECONOMY SERVICE POLICY

Service Oil Company Economy Service Policy includes the following services subject to general conditions shown on reverse side of this policy

- 1. Annual Cleaning and Inspection** of Oil Burner and Boiler or Furnace
- 2. Efficiency Test & Adjustment** for maximum burner efficiency
- 3. 25% Discount on the Repair or Replacement** of the following parts when worn out due to normal use and readily available from normal sources of supply

- 4. 25% Discount on 24 Hour Emergency Service for all Covered Parts**
- 5. Equipment Replacement Allowance.**

\$100 allowance toward replacement of oil fired boiler
\$ 75 allowance toward replacement of central Air Conditioning System
\$ 75 allowance toward replacement of oil fired warm air furnace
\$ 25 allowance toward replacement of oil burner or hot water heater

General Conditions

1. Acceptance of this contract by Service Oil Company (hereafter referred to as SOC) is subject to an inspection of heating equipment by company representatives. Repairs required to bring equipment into condition for coverage under service policy will be billed at prevailing rates.

2. Customer agrees to purchase total requirements of fuel oil from SOC during the term of this agreement. If oil deliveries are stopped for any reason this agreement is automatically terminated. No refund for unexpired time will be made after the termination of this agreement. THIS AGREEMENT MAY BE CANCELED WITHOUT REFUND IF FUEL OIL PAYMENTS ARE NOT RECEIVED WHEN DUE ACCORDING TO TERMS.

This agreement shall be effective only if fully paid for according to terms of 30 days or less after invoice date. For customer's convenience, this invoice may be incorporated into customer's fuel oil budget payments.

3. Agreement does not include replacement of parts of or service to BOILER, FURNACE, RADIATION of DOMESTIC WATER SYSTEMS or any other service or parts not specifically noted in agreement. All such service and parts will be billed at the prevailing rates.

4. Agreement does not cover damage due to oil leakage, equipment failure, failure to deliver prompt service due to circumstances beyond our control, etc. Agreement is subject to immediate termination if service is not performed by SOC authorized employees or agents.

5. Agreement does not cover damage due to failure of customer to order fuel, if not on automatic delivery, or damage due to low water cut off. THIS CONTROL SHOULD BE FLUSHED BY HOMEOWNER PERIODICALLY. CUSTOMER SHOULD CHECK WATER GAUGE LEVEL PERIODICALLY TO AVOID DAMAGE DUE TO LACK OF WATER IN BOILER. Calls found to be resulting from these occurrences will be billed at prevailing rates.

6. Fuel flow problems from outside tanks are not covered by this agreement.

7. Service of a non-emergency nature will be scheduled during normal operating hours. Any non-emergency night or weekend call will be billed at prevailing rates.

8. Subject to minimum fuel oil purchases, Policy will automatically be renewed annually, but may be canceled by customer or SOC within 30 days of invoice date. No refunds will be granted after this time.

9. Equipment allowance issued only on Service Oil Company installations.

10. No refunds will be granted upon cancellation of this policy.
